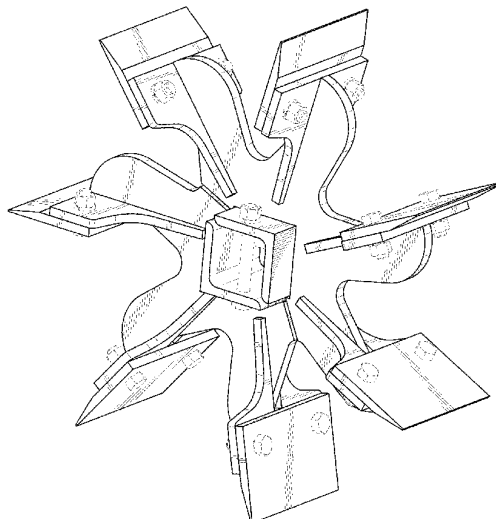
(57) **CLAIM**

We claim the ornamental design for a rotor for tractor-towed agricultural implement, as shown and described.

**DESCRIPTION**

FIG. 1 is a right perspective view of a rotor for tractor-towed agricultural implement showing our new design;

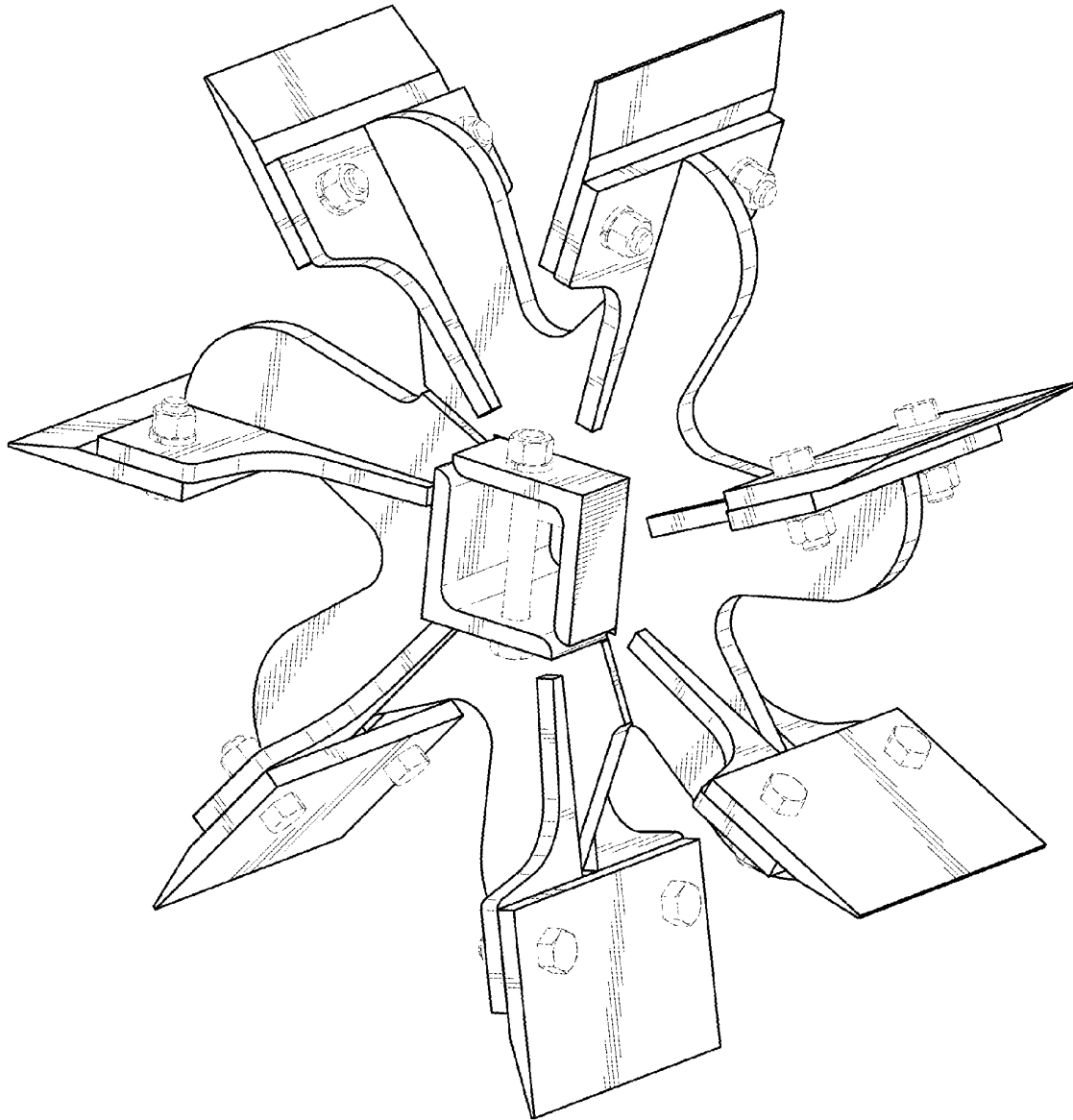

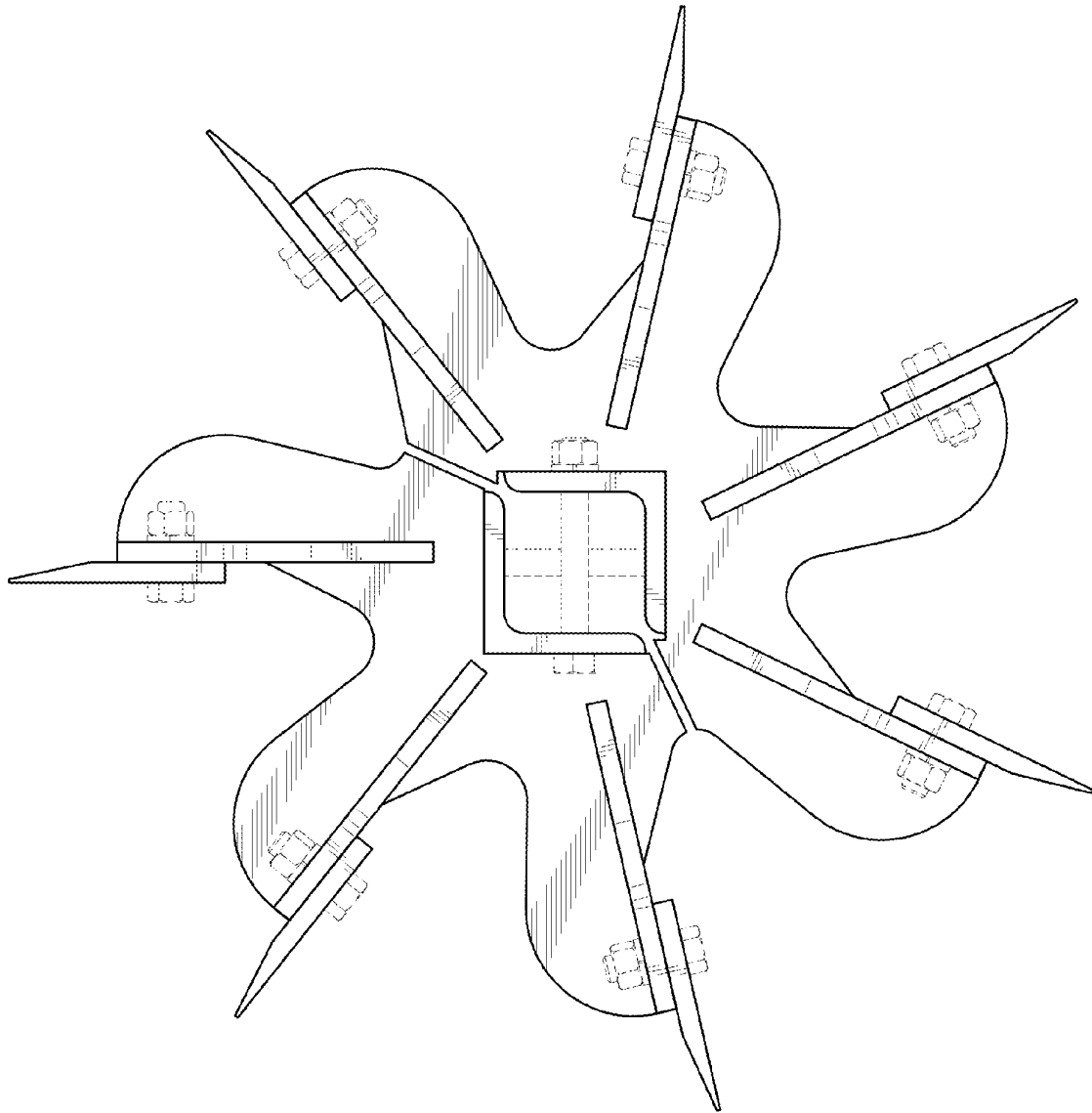

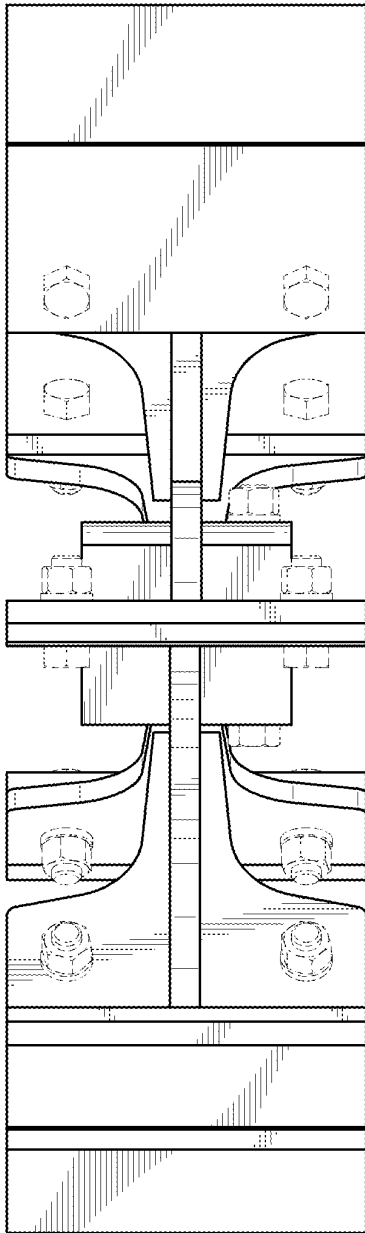

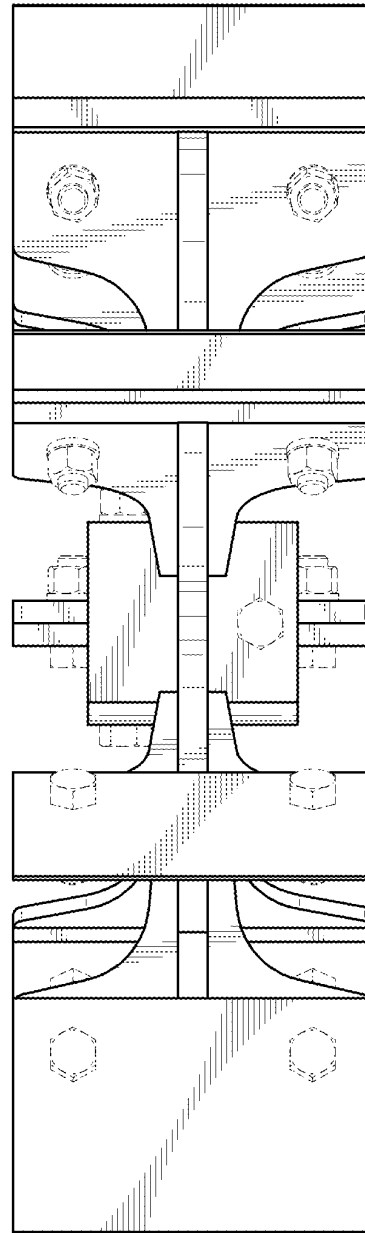

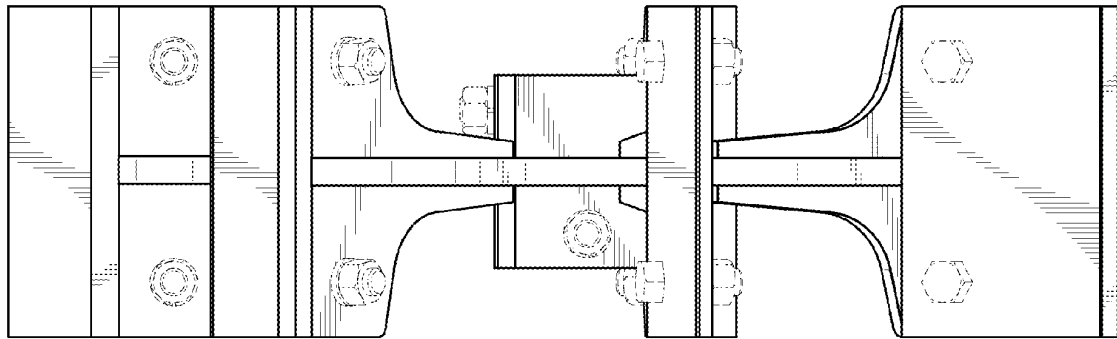

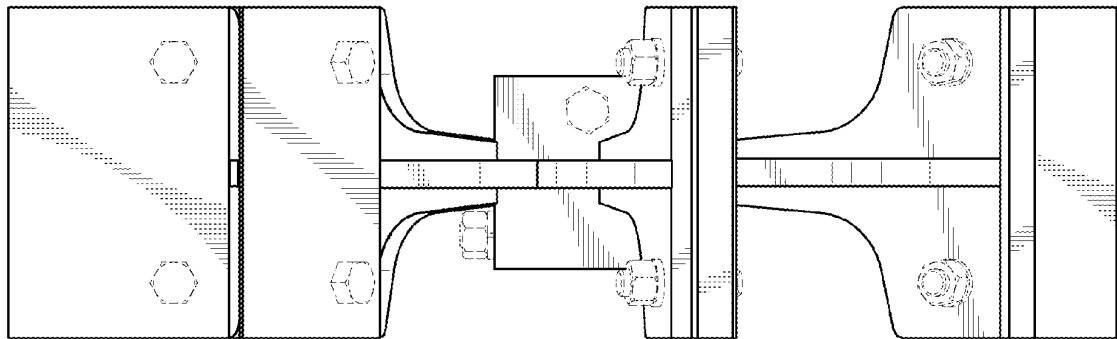
